

CITY OF KINGSFORD RESOLUTION

RESOLUTION ESTABLISHING THE SALARY AND
COMPENSATION TO BE PAID TO APPOINTED OFFICERS AND
CERTAIN OTHER EMPLOYEES OF THE CITY

WHEREAS, Kingsford Code of Ordinances, Section 2-61 requires that the City establish the salary and compensation paid to appointed officers and all other employees of the City by resolution, and

WHEREAS, to be in compliance with PA 152 of 2011 the non-union full-time employees are required to pay 20% of the costs of the provided health care insurance plan beginning July 1, 2012 and per annual resolution of the City Council, and

WHEREAS, at a regular meeting of the City Council, held on July 6, 2020 public disclosure was made as to the compensation to be paid to non-union employees and officers of the City, and

WHEREAS, after due consideration and discussion, by virtue of motion duly made and seconded, it was:




